The meeting of the SSCA General Membership was called to order at the Pitts Center at 7:00 PM by Tisa Head President SSCA and a quorum was established.

Approval of Agenda

The agenda distributed earlier by Tisa Head. A motion was made and seconded to approve the agenda and was unanimously approved.

Approval of Minutes

The Minutes of the July 11, 2022, General Membership Meeting were provided at today's General Membership Meeting. A motion was made and seconded to approve the Minutes and was unanimously approved.

President's Comments

Tisa Head

Thank you for coming this evening. It is important that we have a quorum at this meeting, since we do have a couple of important things that need to get a Membership vote on: Our 2023 Budget and some changes to our Bylaws.

Since our last General Membership meeting, we got the results of our first SSCA Survey. Hopefully, you all had a chance to read the communication that provided those results. The survey was extremely helpful in informing the Board on decisions that needed to be made for the 2023 Budget. Number 1 being the move forward on building Pickleball courts. This was overwhelmingly the number one new amenity that members wanted. We think we have developed a budget that will allow us to get this done, with member contributions and with undesignated reserves that will be replenished over the next couple of years. We have already identified an ad hoc committee that has a charter approved by the SSCA Board directing the work that needs to be done to get this project completed. You will receive periodic updates on that progress as we begin work.

There were many other ideas and suggestions that came out of the survey, that we have acted on. One request was more Yoga – and starting this week, we are offering yoga classes here at the Pitt Center, by certified instructors. These classes, at this point, are free! Provided by Outer Banks Yoga. We are very appreciative of their offer to do these classes for our members.

We have also begun work to identify if we have space at our existing marinas for some additional slips. We may have the potential to add 4-6 more slips, but there is work that needs to be done before they will be completed. Hopefully, early next year if we are able to get the permits to do so.

We will begin work on sprucing up Triangle Park (where the Cell Tower is), so you will see work going on there over the next couple of months. The Town will also provide a new sign, *Welcome to Southern Shores, A Community of Volunteers* – that will hide the big green electrical box there on the corner. I think the Mayor and I both agree, we could certainly make that a more appealing entrance into Southern Shores!

One more idea we are pursuing is a community garden - something that came up high on the list of desired amenities. I have met with the mayor, and this may be something that we can do, working in partnership with TOSS. Stay tuned for more information, and a request for volunteers to get this done!

On another subject, I want to mention that members will be receiving an email with the slate of nominees to fill next year's Board vacancies. Terms that are expiring for: Jim Kelleher (VP), Randy Grimes (Membership Director), Bob Baculik (Beautification – or Marina's and Parks), and Tisa Head (President). Our nomination committee identified four nominees to fill these vacancies. They are:

Don Pratt, George Kirby, Tisa Head, and Joel Newton

And finally, we will kick off our 2023 Membership Renewal and New Member drive in the next couple of weeks. The online renewal application, with the ability to make payment online, will be live soon. Current members will receive a notice to go online to renew. We will also work to identify Southern Shores residents who are not members and encourage them to join! We had over 1,800 members join this year, and we know there are a few hundred more out there that are NOT members, and we would love to get them to join!

Treasurer's Report

Our Financial Status continues to be Great as reflected in the handout provided. Here's some specific highlights:

- Balance Sheet:
 - Our total current funds through the end of September have increased by \$23,548.
 - We have opened Reserve/Savings accounts in two addition banks to provide full FDIC coverage.
- P&L Summary:
 - At this point, from our budget position, we are on track and should easily totally fund our annual Capital Fund Reserves commitment.
 - During the remaining months, we should exceed our budgeted revenue and spend less than our budgeted expenses.
 - Additional revenue (~\$17K+) will be received from:
 - Boat Club GAM/Events/Sales; (\$2,500)
 - Cell Tower lease agreement payments (\$14,000); and
 - Savings/MM interest (\$800)
 - Operating Expenses will total about \$80,000 for Staff, Admin and Property costs.
 - Thus, we project a Net Income for this year to be \$60K+
- Reserve Funds: We continue our commitment to manage Reserve Funds to meet our current and projected needs.
- Audit Status:

- Final review of our 2020 audit is in progress – no surprises yet; our 2021 audit has begun but it will not be completed until early next year.
- Ernie Dash will provide a full report at the next General Membership meeting.
