Town Report: Cliff Ogburn

Cliff Ogburn thanked SSCA for working so closely with Toss and provided information regarding the following projects, efforts:

- Sign at Triangle Southern Shores a community of volunteers.
- 583 responses to the towns land use survey.
- Site plan approved for new emergency management system station.
- \$250K grant for new pathway along RT 12 (Duck Road).
- Opening of Marshalls scheduled for late spring 2023.
